Candidates complete field hours in classrooms and classroom settings that include students with disabilities as well as students who are ELL students in urban settings. All education teachers currently take five credit hours of course work related to education of students with disabilities including a focus on collaboration and adaptations. Our new program designs now include an additional required ESL methods course and an expanded the Special Education methods course which changed from 2 hours to 3 hours.

Teacher Training

1. Provide a description of the activities that prepare general education teachers to:

a. Teach students with disabilities effectively

All teacher education candidates take Special Education 356, Collaboration & Adaptation in the General Education Setting. This is a special education methods course which focuses on the characteristics of students with disabilities, special education law, collaboration (including co-teaching) and development of adaptations or modifications. In the course, candidates learn specific methods for teaching students with disabilities effectively. One of the main focuses of the course is Universal Design for Learning. Candidates learning the three main principles of UDL and develop lesson plans demonstration implementation of these principles. Candidates also learn different approaches to co-teaching. Also, the special education methods course has been expanded from 2 credit hours to 3 credit hours to allow for substantially more content related to instruction of individuals with disabilities.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

All teacher education candidates take Special Education 322, Characteristics of Students with Disabilities and the Special Education Process. In this course, candidates study the Individuals with Disabilities Education Act. They gain knowledge about special education law as it related to Individualized Education Programs and their responsibilities as a member of an IEP team. During student teaching, efforts are made for candidates to participate along with their cooperating teacher in an IEP meeting.

c. Effectively teach students who are limited English proficient.

Our Elementary candidates take three courses in ESL that prepare them for working with ELL. These courses are: Foundations of Language Minority Education, Assessment of English Language Learners and Methods for Teaching English Language Learners. Candidates in our Secondary Education programs take a course entitled Language, Culture and Diversity, which is housed in our ESL endorsement program.

a. Teach students with disabilities effectively

We offer an undergraduate major in special education, and graduate programs that lead to a Masters of Science in Special Education. In all three programs, candidates take a course that introduces them to characteristics of students with disabilities, legal foundations and general methods. They take courses in teaching students with disabilities, academic methods courses for elementary, middle and secondary students. They also take a class for working with students who have moderate to severe disabilities. All students in the special education program take a class that addresses classroom management to include interventions for students whose behavior severely disrupts learning or leads to lack of safety. They also address Social emotional learning and building pro-social skills.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Candidates in our traditional programs take a class that specifically addresses IEPs. They develop an understanding of the IDEA provisions as they relate to IEPs including parental rights. They focus on transition planning as well. In addition, they develop skills in progress monitoring: effective ways to progress monitor and how to effectively share it with other team members, families and students.

c. Effectively teach students who are limited English proficient.

In the undergraduate special education minor, candidates take 3 courses in special education that lead to an ESL state approval. Candidates take a course on school and culture which focuses, in part, on working with families in our diverse society. Included is a focus on how views of culture are developed and need to be examined by candidates and how to effectively work with students and families who differ by race, ethnicity, language and other cultural markers. Candidates in the graduate programs in special education take one course that specifically focuses on education of ELL. In addition, they take the course on school and culture/child, family and community relations which is described above. The ways some members of various cultures view disability is addresses as is the way these views may impact their goals for their children throughout their education and post-secondary aspirations. There is a focus on issues related to identifying a student who is an ELL who may or may not have a disability. In methods classes, there is a focus on identifying methods to support learners with special needs who are also ELL.
